EMPLOYMENT IN MALTA

Non-European Union (EU) citizens need a residence permit to work in Malta. To qualify for employment, the first step is to secure a job offer from a Maltese employer.

When granted a residence permit based on employment, it remains valid as long as the main conditions are still met, including the specific job title, employer, and duration of employment. These details are also mentioned on the residence card issued to the non-EU national.

If any of these conditions change or are no longer met, the permit holder is required by law to inform the Expatriates Unit within the Identity Malta Agency and promptly return the residence card. Failure to comply would violate Malta's Immigration Act (Cap. 217) and could lead to actions by the Principal Immigration Officer.

It's important to note that employment must take place in Malta, and possessing a residence permit does not grant the right to work in other European Union countries.

The most common types of residence permits related to employment are:

- SinglePermit
- Self-Employment
- Employment lasting less than six (6) months
- · Blue Card
- Intra-Corporate Transferee

NB. PLEASE NOTE THAT YOU WILL NOT BE ABLE TO WORK AS SOON AS YOU ARRIVE IN MALTA YOU ARRIVE IN MALTA AS YOU NEED TO PREPARE THE FOLLOWING.

- 1. Health Screening (health approval from the health authority may take up to 15 days)
- 2. Health Insurance
- 3. Lease Agreement
- 4. Housing Authority Approval (housing authority approval from the housing authority may take up to 15 days).

Once the above documents are available a biometric appointment with Identity Malta needs to be scheduled. Expatriates Booking - Identity Malta Agency | Scheduling and Booking Website

This process may take up to **two months** so please ensure that you have enough money to cover your expenses for the first two to three months.

Why should the landlord register the property to obtain housing authority approval?

Registration will help local authorities to ensure that landlords comply with legislation and meet the required standards.

Identity Malta requires said approval in order to process the single permit application.

After the implementation of the law on private residential leases on January 1, 2020, a joint collaboration was initiated between the Housing Authority and the Identity Malta Agency. The main objective of this collaboration is to streamline the process for foreign residents in Malta who rent properties in the country, enabling them to obtain a valid residence permit as quickly and efficiently as possible.

During the discussions that led to the development of a procedure aligned with the new law, the Identity Malta Agency decided to require a letter of approval issued by the Housing Authority. This letter serves as confirmation that the applicant holds a secure title on each residential lease contract that falls within the parameters of the new law. This approval is important for foreign residents renting properties in Malta as it allows them to apply for the relevant permits, which if granted allows them to live and work in the country legally.

Furthermore, both entities reached an agreement regarding lease contracts with a duration of six months. In such cases, when the time comes to renew the single permit, the applicant must provide the initial lease contract that was originally submitted with the previous application. This refers to the lease between the expiration of the first contract and the expiration date of the single permit. Additionally, the applicant must also present the current lease contracts, each having a duration of at least six months. This agreement ensures a standardized and efficient process for renewing permits and maintaining compliance with the law for foreign residents in Malta.

Shared Residential Space

Lease of a **shared residential space** means the lease of a separate space in an apartment or building, with shared amenities like the kitchen and bathroom facilities.

Explanation of a shared residential space lease:

- The lease duration is six months;
- The lessee may be released from the contract at any time by giving one week's prior notice to the lessor by means of a registered letter;

Short-Let contracts are applicable only to the following categories:

- Temporary foreign workers employed for six months or less.
- Students pursuing short courses lasting less than six months.
- Foreign lessees not intending to establish ordinary residency in Malta.
- Residents requiring an ordinary residency for a brief period of less than six months.

Explanation of Short-Let Contracts:

- Lease Duration: The contract duration is fixed at six months.
- Mandatory First Month: The lessee must occupy the property for the initial month of the lease.
- Early Termination: After the obligatory first month, the lessee can terminate the contract by providing at least one week's notice to the lessor through a registered letter.
- Non-Renewal: Short-Let contracts cannot be renewed beyond the initial six-month period.

A **Long Private Residential Lease** must have a minimum duration of one (1) year. Here's an explanation of lease contracts for different durations:

One-Year Lease Contract:

- The lessee is obligated to stay for the first six months.
- After the initial six months, the lessee can terminate the contract by providing at least one (1) month's notice to the lessor through a registered letter.
- If the lessor decides not to renew the lease, they must notify the lessee three (3) months before the contract's termination, using a registered letter.
- If the lessor fails to give timely notice, the lease automatically renews for another year.
- Although the minimum mandatory duration is one year, the lessor and lessee may agree to a longer lease if desired

Two-Year Lease Contract:

- The lessee is obligated to stay for the first nine months.
- After the initial nine months, the lessee can terminate the contract by providing at least two (2) months' notice to the lessor through a registered letter.
- If the lessor does not intend to renew the lease, they must inform the lessee three (3) months before the contract's termination, using a registered letter.
- If the lessor fails to give timely notice, the lease automatically renews for another year.

Lease Contract for Three Years or Longer:

- The lessee is obligated to stay for the first twelve months.
- After the initial twelve months, the lessee can terminate the contract by providing at least three (3) months' notice to the lessor through a registered letter.
- If the lessor does not intend to renew the lease, they must inform the lessee three (3) months before the contract's termination, using a registered letter.
- If the lessor fails to give timely notice, the lease automatically renews for another year.

To find accommodation in Malta, you have several options available:

- 1. Real Estate Agents: Contacting a real estate agent can help you find suitable accommodation quickly. They can provide you with options that match your preferences and budget. Keep in mind that using an agent may involve paying a fee or commission.
- 2. Direct from Owner: Renting directly from the owner can be more cost-effective as you avoid agent fees. However, be cautious and ensure the owner is trustworthy to avoid potential scams.
- 3. Social Networks: Many accommodation listings are posted on social media platforms, especially on Facebook. Look for specialized groups or use relevant keywords to find accommodation listings, such as "accommodation in Malta," "rent a flat in Malta," or "Malta sharing accommodation."
- 4. Online Marketplaces: Check online marketplaces like Maltapark for accommodation listings.
- 5. Classified Ads: Look for accommodation listings in newspapers like the Times of Malta.
- 6. Word-of-Mouth: If you know people in Malta, ask for recommendations or inquire if they know of any available accommodations.

Tips:

- Start your search before arriving in Malta to have some options lined up.
- Be cautious of potential scams, especially if you are renting from abroad. Verify the legitimacy of the property and owner before making any payments.
- Arrange viewings either before or upon arrival, and consider using phone communication to make arrangements once you're on the island.
- By exploring these options and being vigilant in your search, you should be able to find suitable accommodation in Malta.

When choosing your accommodation in Malta, consider the following factors:

- 1. Reversible Air Conditioning: Opt for accommodation equipped with reversible air conditioning, especially if you are moving to Malta during the hot summer months. AC will help you stay comfortable during hot summers and provide some warmth in the relatively mild winters.
- 2. Location and Parking: If you plan to rent in busy areas like Sliema or Saint Julian's, consider properties with private parking as parking spaces can be limited in such crowded areas. However, if you choose a less crowded area in the countryside, street parking should be safe and readily available.
- 3. Proximity to Public Transport: Check the availability of public transport near your accommodation. Maltese buses cover most areas, but if you don't have a car, ensure that you have easy access to bus stops for your daily commute and to explore the islands.
- 4. Safety: Research the safety of the neighbourhood where the accommodation is located. Look for areas with low crime rates and a secure environment.
- 5. Amenities and Services: Consider the proximity of essential amenities such as grocery stores, pharmacies, hospitals, and schools to ensure convenience in your daily life.
- 6. Budget: Set a budget for your accommodation and stick to it. Be mindful of additional costs such as utility bills and potential maintenance expenses.
- 7. Length of Stay: If you plan to stay in Malta for a short period, a furnished rental might be more practical, whereas long-term residents might prefer an unfurnished option.

Additional information regarding Malta Public Transport

Currently, the primary mode of public transportation in Malta consists of a network of route buses. There are no underground or metro systems, and the previous railway service, which existed in the late 19th and early 20th centuries, now only has remnants of old train station buildings.

Operated by Malta Public Transport, the bus routes offer extensive coverage throughout Malta and Gozo from 5:30 am to 11 pm. Additionally, there is a night service available on Friday and Saturday nights and public holidays.

Although traveling by bus may not be the quickest option, it is undoubtedly the most economical one, aside from walking or cycling. If you can exercise some patience and don't mind a leisurely journey, the bus service is worth considering.

With over 80 bus routes, you can easily reach essential locations on the islands, including the Malta International Airport, the Valletta cruise liner terminal, and the Gozo ferry terminals at Cirkewwa and Valletta, from where you can catch a ferry to Gozo.

The buses are generally efficient, serving major tourist areas and points of interest, although occasional disruptions may occur. The main bus terminus is located just outside Malta's capital, Valletta, with other significant bus nodes at the airport, Bugibba, Cirkewwa (Gozo ferry), and Victoria (Gozo's largest town).

For planning bus trips, you can use the Malta Public Transport website, specifying your departure point and destination to see all available route options. Alternatively, using Google Maps to search for bus stop names rather than place names can yield better results.

To pay for single tickets, contactless payment with a VISA credit or debit card is accepted onboard the bus. However, multi-day tickets, such as the 'Tallinja card,' are best purchased from ticket booths or machines. For visitors staying seven days or more, there are two suitable options:

Explore card: Costs €21 (adult) or €15 (child) and provides unlimited bus travel for seven days.

Explore Plus Meep card: Costs €39 and offers seven days of unlimited bus travel, two ferry trips on the Valletta ferry, and a one-day hop-on/hop-off bus tour or a boat trip to Comino.

Another option is the 12 Day Journey Card at €15, which offers reduced fares for 12 journeys or 6-night trips.

You can purchase bus tickets and passes from various locations, such as the Malta Public Transport sales office/booth at the airport, Sliema Ferries, Valletta bus terminal, Bugibba bus terminal, and Victoria (Gozo) bus terminal. Alternatively, you can buy tickets directly from the bus driver, but it is advisable to have exact change to avoid inconveniences.

Unfortunately, bus tickets and passes are not available for online purchase at this time. Hence, the most convenient option is to plan your preferred ticket/card type and buy it at the airport if your flight arrives during the opening hours of the sales office.

Exchange your foreign Driving Licence

Any person holding a licence issued outside Malta and the European Union shall be entitled to drive in Malta for a period not exceeding twelve months from the date of his last entry into Malta. The validity, duration and expiry of the Maltese counterpart issued will be the same as per the details of the driving being presented and exchanged.

Any holder of a driving licence issued in the following countries, who takes up normal residence in Malta shall be entitled to have his driving licence exchanged for an equivalent Maltese licence:

- Another Member State of the European Union (EU), or
- · A member state of the European Economic Area (EEA) namely Norway, Iceland and Liechtenstein; or
- · Switzerland; or
- · Australia: or
- The United Arab Emirates (UAE); or
- The United Kingdom (UK).

Driving licences issued within the European Union shall be recognised in Malta as long as they are valid in Member State of issuance.

National provisions regarding the restriction, suspension, withdrawal or cancellation of a driving licence shall apply to holders of a driving licence issued in the above-mentioned countries who have their normal residence in Malta.

All matters concerning Driving Licence in Malta are regulated by the Motor Vehicles (Driving Licences) Regulations - **S.L. 65.18**.



The Internet in Malta

Internet service providers also offer a wide range of packages at different rates. To acquire an internet connection at home, visit the nearest branch of your service provider with the following documents:

- Your resident permit or passport
- The owner's authorization if you are renting accommodation

Your internet connection should be set up within a few days. Again, carefully review the documentation for terms and conditions. If you do not intend to stay in Malta or are unsure of the length of your stay, it's best to avoid a contract period with early termination fees.



If you are involved in an accident in Malta, follow these steps:

Call for Help: Dial the emergency number 112 to report the accident and get assistance from relevant authorities, including doctors, firefighters, and police.

- Provide Information: When speaking to the emergency operator, be clear and provide essential
 details about the accident, such as the location, type of accident, and any injuries
 or medical emergencies.
- Seek Medical Attention: If there are injuries or medical problems resulting from the accident, prioritize getting medical attention. The emergency services will dispatch appropriate medical personnel to the scene.
- Cooperate with Authorities: Stay calm and cooperate with the police and other emergency responders at the accident scene. Provide necessary information and cooperate with any investigations.
- Document the Accident: If it is safe to do so, gather information about the accident, such as taking photos, noting the location and time, and exchanging contact information with other parties involved, if applicable.
- Notify Relevant Parties: If necessary, inform your insurance company or relevant authorities about the accident as soon as possible.
- Know Your Rights: Be aware that both hospitals in Malta and Gozo offer excellent accident and emergency care facilities, and these services are provided free of charge.
- Remember, safety should always be a priority. If you are unsure about what to do in the aftermath of an accident, it's best to seek guidance from the emergency services and follow their instructions.

What is a real police emergency?

A real emergency is one that poses an immediate threat to your life and property, such as, personal physical attacks and break-ins. Other situations that we consider emergencies are the following:

- Traffic accidents with fatalities and/or injuries
- Bomb threats.

If your emergency or the one that you are witness to requires police assistance, dial 112 immediately.

When you dial 112, we will assess whether your emergency requires our help. In this case, you will be immediately assisted.

Public Hospital

Mater Dei in Msida is the biggest public hospital in Malta. It offers a 24-hour, 365 days-a-year emergency department with highly trained staff. The department is dedicated to those seeking treatment for an urgent medical problem related to an illness or accident.

For those who have no need for an ambulance, the accident and emergency department of Mater Dei Hospital can be reached by bus, car, or taxi. The building is well-indicated, so you will be able to find the place easily.

In order to make use of the public hospital you need to have a valid residence permit together with a national insurance number.

Is it difficult to open a bank account?

Opening a bank account in Malta can be challenging for expats and foreigners, and the process might not be as easy as stated by some major banks like HSBC, BOV, and BNF Bank. The strict conditions and requirements can make it difficult for individuals to successfully open a bank account in Malta.

As an alternative, many expats and even Maltese residents are turning to online banks. Online banks are fully-fledged banks that offer a range of banking services, similar to traditional banks. The key difference is that online banks do not have physical branches; instead, all banking services are conducted online through web or mobile applications. TAXAND NATIONAL INSURANCE



If you live in Malta and are from there, you have to pay taxes on money you earn in Malta and from other countries, even if you don't bring that money to Malta.

If you live in Malta but are not originally from there, you have to pay taxes on money you earn in Malta and from other countries, but only if you bring that money to Malta. Money brought to Malta by people who used to live abroad or by foreigners moving to Malta is not taxed because it's considered as money earned and taxed outside Malta.

People from Malta usually use their ID numbers for taxes, so they don't need a separate tax number. Foreigners usually get a nine-digit tax number.

If you're a foreigner living in Malta, you have to register for taxes, whether you work or not. European Union (EU) citizens who have a social security number don't need to register separately for a tax number. Also, non-EU citizens who have a single permit are automatically registered and don't need to get a tax number. Others need to apply for a tax number using the Expatriates Registration form **Expatriates taxpayer registration** (gov.mt)

What is the difference between single, married or parent?

Malta uses a progressive system of tax brackets for calculating how much income tax to levy. The bracket you fall into depends on whether you're filing as an individual, couple or parent.

Any person in working in Malta has to pay his/her respective tax as per table above.

Married couples: Couples in Malta who elect to have their income pooled. If both partners work and make a relatively similar income, it is usually advantageous to elect for the individuals' scale. That's mainly because the top tax bracket for married couples and individuals kicks in at the same threshold. Non-employment income, such as rental income from an asset the couple owns together, is assigned entirely to the partner with a higher income.

Parents in Malta, who have their income tax individually. To qualify for the parent rates, you must have custody of a child under age 19. (Or a child enrolled in tertiary education in Malta who is under 22.)

This rate can be used by single, widowed, separated, divorced parents and also married couples with children who are calculating their tax as individuals. If a divorced couple does not share custody of their child(ren), the parent without custody may not use this scale.

What is considered illegal in Malta?

A crime is an action or omission which constitutes an offence and is punishable by law, usually by a fine or by imprisonment. The below is a table which lists some of the offences. This list in not exhaustive.



LEGAL MATTERS



1. Illegal Immigration	Please ensure you renew your work permit on time.
	In case of change of employer, TCN's have only 10 days grace period to find alternative employment and submit an application to Identity Malta.
2. Forgery of Documents	It is important that documents are true to the best of your knowledge. Tampering of documents may be considered a crime.
3. Theft/shoplifting	Whether you commit a trivial offence or not, theft is illegal in Malta. If you need something ask for permission.
4. Alcohol Abuse	Definitely not at the place of work.
5. Violence	Physical abuse, psychological abuse, Emotional and Financial abuse are not tolerated in Malta.
6. Harassment	Any type of harassment (sexual, stalking etc) is considered as a crime.
7. Rape/Sexual Assault	Victims are to seek medical and police assistance immediately. Offenders are criminally liable to such an act.
8. Usury	This means an action or practice of lending money at unreasonably high rates of interests. Do not go to loan sharks if you require financial assistance. This is illegal in Malta. Only bank and authorised companies can lend money.
	Do not sign any documents or blank pages without being duly informed of what the document entails. Read the document carefully. If you do not understand the content, please show it to someone competent to guide you.
9. Withholding of passport/ identification documents	This is illegal. Please keep safe important documents to yourself.

10. Negligence	Negligence can cause accidents which may cause death or grievously bodily harm (serious injury) to your colleagues, friends, family members, other third parties. It is a MUST that you adhere to the Health and Safety policy, both of the Company and our clients where you will be assigned at.
11. Driving without a valid licence	driving without a valid driving licence is an offence. Apart that you will not be covered by insurance.
